

AMENDMENT OF CHARTER

Pentagon Federal Credit Union

McLean, Virginia

Charter No. 00227

Section 5 of the charter shall read as follows:

"The field of membership shall be limited to those having the following common bonds:

1. Civilian and military employees of and persons regularly attached to the Department of Defense who work in the Pentagon Building;
2. Civilian and military employees of the Department of the Army and the Department of the Air Force who work in the District of Columbia, Arlington or Fairfax County, Virginia, or the City of Alexandria, Virginia, except those employees who are stationed at:
